CHASE Spotlight



Each quarterly newsletter will spotlight one CHASE Partner. The idea is to highlight a company that is providing critical infrastructure to our state. As the CHASE program continues to grow, AKOSH Consultation expects to highlight other partners that work with our program, as well as various associations and support companies.

This quarter we'd like to shine the spotlight on **H5 Construction**. H5 is an Alaskan General Contractor based in Wasilla, AK. They complete a variety of projects from renovations to new commercial constructions throughout the Matsu Valley, Anchorage, Kenai Peninsula, and Fairbanks. The company has grown from a staff of two in 2016 to a staff of 50 in 2021. They completed a number of high-profile projects such as Vista Rose Senior Apartments, Sonic, Planet Fitness, and TAG Plaza. They are currently working on The Shoppes at Sun Mountain, a 30-acre, 300,000 sq. ft. mixed-use project located off the Parks Highway with an estimated \$90,000,000 price tag.

Background: The first interaction with AKOSH Consultation was an off-chance meeting that occurred when an AKOSH Consultation employee drove by one of their jobsites and noticed a potential safety issue. The supervisor onsite was quick to abate the hazard. Although this chance meeting encounter was short, the relationship between AKOSH and H5 continued. Over the next two years, many conversations took place about the need to build a safety foundation for the company since it was growing at a rapid pace.

After an Enforcement action took place on one of their jobsites, H5 worked with a consulting firm as well as AKOSH Consultation. This combination of consulting resulted in a rapid culture change within the company. Since that time, H5's relationship and partnership with AKOSH has grown tremendously. AKOSH completed 11 safety and health consultation visits on five different H5 project sites throughout the phases of construction since 2019. These visits consisted of hazard identification, training, and program development. After a complete overhaul of their safety and health program, H5 became a CHASE-Blue member on June 3, 2020.

The company's safety culture has grown exponentially since their partnership began with AKOSH in 2020. H5 maintains less than ONE recordable injury per year. In addition, H5 provides a variety of training to their employees to ensure they have the depth and knowledge to continue to perform their jobs safely.

As H5 continues to grow, there is no doubt that they will do it safely.
