

URL Address: http://almis.labor.state.ak.us Contact: Dan Robinson (907) 465-6036 Alaska's unemployment rate rose seven-tenths of a percentage point in December to 8.0 percent. Although unemployment typically rises in December, the 2003 increase was slightly larger than in recent years. The comparable national rate (not seasonally adjusted) fell two-tenths of a percentage point to 5.4 percent. Dan Robinson, an economist with the Alaska Department of Labor and Workforce Development, reported the numbers.

The number of unemployed Alaskans rose from 25,093 to 27,462 in December. The increase was marginally higher than 2002's November-to-December increase.

All of the state's six economic regions saw higher December unemployment rates, with the most noticeable jumps coming in the Gulf Coast and Southeast regions. Within the Gulf Coast region, both the Kenai Peninsula and Kodiak Island Boroughs recorded large December increases in unemployment.

In several Southeast communities, claims for unemployment benefits, one of the inputs used to calculate the unemployment rate, increased dramatically. For example, the Wrangell-Petersburg area saw claims rise from 172 in November to 264 in December. Claims in Sitka jumped from 164 to 225, and in the Prince of Wales-Outer Ketchikan area the number increased from 174 to 238.

Anchorage enjoyed the state's lowest unemployment rate in December by a wide margin. At 5.2 percent, Anchorage's rate is at least 1.7 percentage points lower than any other area in the state. The unemployment rate in Fairbanks rose by six-tenths of a percentage point to 7.0 percent, while Juneau's rate climbed five-tenths to 6.9 percent.

Wage and salary employment estimates for December showed a decline of 2,400 jobs. Seasonal job losses in the construction and seafood processing industries accounted for nearly all of the reductions. The health care industry continues to be a bright spot, adding about 500 jobs in December and 2,400 over the last twelve months. Across all industries, the state has added an estimated 5,100 jobs to the economy since December 2002.

They are considered not in the labor force.
