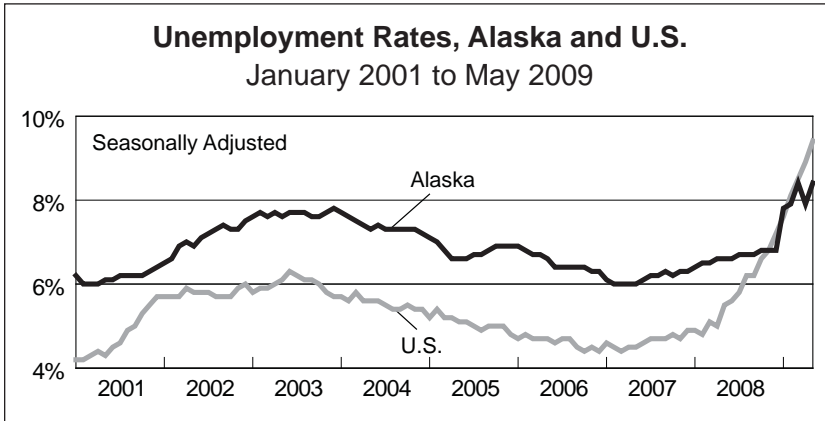

### Unemployment rate at 8.4 percent in May



Alaska's seasonally adjusted unemployment rate rose five-tenths of a percentage point in May to 8.4 percent, according to the Alaska Department of Labor and Workforce Development. April's rate was revised down one-tenth of a percentage point to 7.9 percent.

The state's unemployment rate has climbed 2.4 percentage points since early 2007's low of 6.0 percent, but that increase is relatively mild compared to the U.S. rate, which has increased a full 5 percentage points over the same period.

The state's payroll job count shows a similar pattern. Over-the-year growth in Alaska has consistently slowed in 2009 and May estimates show a decline of 1,200 jobs from May 2008's level. But national job losses have been much more severe. From May 2008 to May 2009, the nation's payroll job count fell by 4 percent compared to a loss of just 0.4 percent for Alaska.

From April to May, the state added 13,500 jobs as the state's very seasonal job market continued to build toward the peak employment months of July and August. The over-the-month growth came from a variety of industries including construction, retail trade, restaurants, and hotels and lodges.

But seasonal increases have been smaller than in recent years. From 2006 to 2008, the average gain from January to May was about 28,000 jobs. This year, the state has added about 23,000 jobs over those four months.

Many individuals in rural Alaska do not meet the definition because they have not conducted an active job search due to the scarcity of employment opportunities.

<sup>1</sup> Unemployment rates that are not seasonally adjusted should not be compared with those that are.

<sup>2</sup> Because of the creation of new boroughs, this borough or census area has been changed or no longer exists. Data for the new borough and census areas will be available in 2010. Until then, data will continue to be published for the old areas.
